INDEPENDENT AUDITOR'S REPORT

To the Board of Directors

We have audited the accompanying financial statements of Literacy Volunteers of Charlottesville/Albemarle (a nonprofit organization), which comprise the statement of financial position as of June 30, 2018, and the statement of activities, functional expenses and cash flows for the year then ended, and the related notes to the financial statements.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free of material misstatements.

An audit involves performing procedures to obtain evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgement, including the assessment of the risks of material misstatement of the financial statement, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. Accordingly, we express no such opinion. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Opinion

In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position of the Literacy Volunteers of Charlottesville/Albemarle, as of June 30, 2018, and the changes in its net assets and its cash flows for the year then ended in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS

NATURE OF ACTIVITIES

Literacy Volunteers of Charlottesville/Albemarle (the Organization) is located in Charlottesville, Virginia and was organized to promote and foster literacy in the City of Charlottesville, Albemarle County and the contiguous areas. Its primary purpose is to recruit and train volunteers to tutor adults on a one to one basis through the following programs: Workforce Development, Citizenship and Civics Instructions, General English As A Second Language Instruction and Basic Literacy and Numeracy Instruction. The Organization incorporated in November 2003. It was originally an affiliate of Literacy Volunteers of America.

The Organization receives its funding primarily from state, local, city and county government grants. It also solicits private donations and holds fundraising events.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

Net assets, revenues and expenses are classified based on the existence or absence of donor-imposed restrictions. Accordingly, net assets of the Organization and changes therein are classified and reported as follows:

Unrestricted net assets - Contributions and all other revenue sources that are not subject to donor imposed stipulations. Undesignated net assets may be used at the discretion of management to support the mission of the Organization and consist of net assets accumulated from the results of operations.

Temporarily restricted net assets - Contributions that are available for use, but expendable only for those purposes specified by the grantor or restricted by the passage of time. When a donor's restriction is met, temporarily restricted net assets are classified to unrestricted net assets. At June 30, 2018, the balance is \$79,834.

Permanently restricted net assets - Net assets subject to donor-imposed stipulations that they be maintained permanently by the Organization. At June 30, 2018, there were no permanently restricted net assets.

Concentrations of Credit Risk

Financial instruments that potentially subject the Organization to credit risk include cash on deposit with financial institutions in excess of the Federal Deposit Insurance Corporation limit of \$250,000 for each account. As of June 30, 2018, the Organization had no uninsured deposits.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES-Continued

Functional Expenses

Expenses are charged directly to program services, management and general or fundraising in general categories based on specific identification.

Income Taxes

The Organization is exempt from regular federal income taxes under Section 501(c)(3) of the Internal Revenue Code and qualifies as a public charity under Section 509(a)(1).

Grants Receivable

The Organization's receivables at June 30, 2018, consist of amounts due from two local government grants that were awarded during the current fiscal year. No allowance is considered necessary.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Property and Equipment

Depreciation is computed on the straight-line method over the assets' estimated useful lives. Equipment purchased is capitalized at cost; the estimated fair values of donated assets are similarly capitalized.

Donated material and services

During the fiscal year, volunteers have donated time to the Organization in providing its program services. These services are not recorded as contributions in the financial statements, since the recognition criteria was not met.

ADVERTISING COSTS

Advertising costs are expensed as incurred. Total advertising costs for the fiscal year were \$3,727, primarily for the recruitment of volunteers.

NOTES PAYABLE

The Organization entered into a note payable beginning August 10, 2012, to the Jefferson School Community Partnership, LLP. The outstanding principal balance is \$0 as of June 30, 2018. The note was forgiven during the audit year ending June 30, 2018. The note was the product of an agreement between the two parties based on leasehold improvement work performed.

LEASE COMMITMENT
