**TIENE EL DERECHO DE VER LOS ORDENES JUDICIALES ANTES DE PERMITIR UN OFICIAL DEL ICE DE ENTRAR**

## Ejemplo de Ordenes Para Revisar un Lugar:

**Example 1 (Left):** A search warrant from Gloucester County, Virginia. The address is 123 Street #1, Hayes, Virginia, 23072. The warrant is issued to any authorized officer. The judge is Margaret Walker, Clerk. The date is 2010 MAY -4 PH 3:18.

**Example 2 (Right):** A search and seizure warrant from the United States District Court, Eastern District of California. The address is 540 Oak Avenue, Davis, California 95616. The case number is 2:11-SW-0161 EFB. The warrant is issued to any authorized law enforcement officer. The judge is Edmund F. Brennan, U.S. Magistrate Judge. The date is 4-25-2011 at 9:10:00 AM.

1: La dirección exacta esta requerida

2: "Judge" o "Magistrate" debe estar seleccionado después de la firma. ¡No está un orden judicial si solo "Clerk" esta seleccionado!

3: La fecha de vencimiento no debe haber pasado  
(Solo algunos ordenes tiene fecha de vencimiento)

2: La firma debe estar de un juez (Judge) o magistrado (Magistrate)

La orden tiene que tener:

1. La dirección exacta (número de departamento, etc.)
2. La firma de un juez (*judge*) o magistrado (*magistrate*)
  - No solo de una secretaria (*Clerk*)
3. Si tiene fecha de vencimiento, no debe haber pasado

## Ejemplo de Orden de Arresto:

**WARRANT OF ARREST—MISDEMEANOR (STATE)**  
COMMONWEALTH OF VIRGINIA Va. Code § 19.2-71, -72
